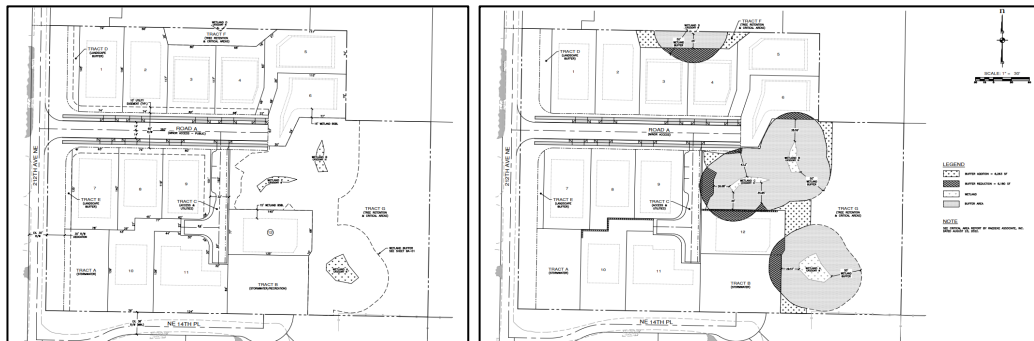

PROJECT DESCRIPTION: The applicant proposes to subdivide five existing R4 zoned parcels totaling 6.62 acres into 12 lots for single-family residential development and demolish the existing structures. Lots 1-9 will have access via a new public road, while Lots 10-12 will have access via a new private road. Two stormwater tracts are proposed to accommodate the storm detention required to serve the projected impervious areas. There are several critical areas on and near the site.

This proposal may include mitigation measures under applicable codes, and the project review process may incorporate or require mitigation measures regardless of whether an EIS is prepared. A copy of the subsequent SEPA threshold determination for the proposal may be obtained upon request.
