RE: Brownstone West Resubmittal Second Extension Request (PSUB2019-00561)

Dear Mr. Brennan,

The City of Sammamish Department of Community Development has received your letter dated January 22, 2021 via electronic email transmittal (**Attachment 1**). In the letter you present a revised submittal deadline extension request for an additional 30 days, until March 13, 2021. A previous extension request was granted for an additional 30 days past the 60-day timeframe on December 11, 2020 to resubmit your application in response to the City's Plan Review Summary Letter dated November 13, 2020. The City grants this second 30-day extension request and as a result the revisions resubmittal deadline has been updated from February 11, 2021 to March 13, 2021.

In your request you state that during the January 5, 2021 meeting "Staff acknowledged that the City's requirements reflect different and to some extent competing priorities, leading to a potential need for deviations and/or departures as allowed and under applicable rules." To clarify, the City's expectation is for an *applicant to meet all applicable Public Works design standards and Town Center Development Codes as adopted*. There may be development standards which an applicant believes preclude development due to a range of circumstances. In these situations, an applicant can apply for a deviation and/or departure from said requirements.

As stated in the City's letter to STCA issued on January 20, 2021, to address the criteria outlined in the development code and public works standards a deviation and departure request should address: how the proposed design alternative provides a public benefit, considers environmental protections (ex. maximize tree retention, minimize soil disturbance, minimize impervious surfaces, etc.), health, safety and welfare concerns, harmonizes development regulations and existing standards to facilitate beneficial innovative design, and does not set a precedent or create a new development standard by default.
